WHAT IS EB-5?

EB-5 is a United States visa program, created by Congress in 1990, that enables foreign investors to obtain a United States visa by investing in a business that will benefit the U.S. economy and create jobs.



IS THE EB-5 PROGRAM RIGHT FOR ME?

Investors must meet 3 initial requirements to qualify for EB-5:

- Make a minimum investment of \$500,000 through an EB-5 regional center.
- Demonstrate that the investment has come from a legal and traceable source.
- Complete background check to assure the investor and/or family has not broken any U.S. Immigration laws or has a past criminal record.

WHAT CAN I RECEIVE BY PARTICIPATING IN EB-5?

- Receive Green Card
- Repayment of investment

Ultimately once the investor satisfies the initial requirements listed above as well as any USCIS requirements and the successful completion of the EB-5 project, the investor should anticipate a permanent green card and ultimately the repayment of the \$500,000 investment.

Investor is Eligible to Apply for U.S. Citizenship

After approximately 5 years from the investor's initial entry to the United States, the investor and eligible family members are then able to apply for U.S. citizenship, if the investor chooses.



Minimum Investment

Have a minimum of \$500,000 USD to invest through an EB-5 regional center, such as U.S. Immigration Fund.



Trace Funds

All investment capital must be obtained lawfully and come from a legitimate source recognized by the USCIS. These sources include but are not limited to salaries, gifts, loans and inheritance.



Background Check


The USCIS requires a background check to assure the investor has not broken any U.S. Immigration laws.

WHY EB-5?

Immigrating to the United States through the EB-5 visa program provides many benefits to foreign investors. Compared to other visa programs - it's fast, predictable and your spouse and unmarried children under 21 can apply with you.

WHAT IS THE EB-5 PROCESS?

The EB-5 process has multiple steps and the U.S. Citizenship and Immigration Services (USCIS) requires various petitions filed within specified timelines. When working with USIF, we can provide some of the best EB-5 immigration attorneys to guide the process, outlined on the next page.



THE EB-5 PROCESS FOR INVESTORS WORKING WITH USIF

The EB-5 process has multiple steps, a summarized version is provided below. Here's a look at the EB-5 Investment process when working with USIF.

PRE-QUALIFICATION

1. INVESTOR QUESTIONNAIRE | USIF provides the potential investor with a questionnaire for general background information to ensure the investor will qualify.

- 2. SPEAK TO A LAWYER | USIF can recommend experienced EB-5 lawyers, or the potential investor can choose one of his/her own. The lawyer will discuss the individual immigration case with the potential investor, and gain an understanding of the source of funds to be used for the EB-5 investment.
- **3. EB-5 DOCUMENTS ISSUED** | After USIF reviews and approves the questionnaire, USIF's foreign representative provides offering documents needed to make a decision about the EB-5 investment.

INVEST

- 4. ANALYZE AND SIGN PROJECT DOCUMENTS | The investor reviews all project offering documents, and consults with advisors on the investment. Once comfortable with the project, the investor signs the offering documents. These documents additionally outline the deposit of the initial investment amount plus any associated fees into escrow bank.
- **5. INVESTOR WIRES FUNDS** | Funds are wired into the escrow account related to the project at the time the offering documents are signed.

- **6. INITIAL APPLICATION** | The investor's lawyer works closely with USIF to prepare the initial application (Form I-526) for the investor and eligible family members.
- **7. I-526 RECEIPT NOTICE** | USCIS will issue confirmation of receipt of the I-526 application.

U.S. CITIZENSHIP


12. APPLY FOR CITIZENSHIP | While U.S. Citizenship is optional, the investor and their eligible family members may qualify to apply for citizenship within 4 years and 9 months after conditional residency (I-526) is obtained, so long as other naturalization requirements are met.

FILE I-829 PETTITION

- 10. FINAL APPLICATION | Within 90 days of the expiration of the investor's conditional green card, the investor's lawyer files an petition for a permanent green card (Form I-829) on behalf of the investor and family, to remove conditions from the two-year conditional green card.
- 11. PERMANENT GREEN CARD | Once Form I-829 is approved, conditions are removed and permanent residency is granted. Investor and eligible family members will receive a ten-year permanent green card, which is renewable indefinitely.
- **12. REPAYMENT OF INVESTMENT** | After USCIS and project requirements have been satisfied, the investor should ultimately anticipate teh repayment of their \$500,000 investment.

CONDITIONAL GREEN CARD CONDITIONAL GREEN CARD

- 8. CONDITIONAL GREEN CARD | Once initial Form I-526 is approved and the investor completes the consular process, the investor and eligible family members obtain a conditional 2-year green card.
- **9. MOVE TO THE UNITED STATES** | The investor and their family may move to the U.S. with their conditional green card, which remains valid for 2 years.
